

You also agree to waive every claim which you might have, now or in the future, as against: (i) any landowners (including the Province of Manitoba) on which Snoman's trail system operates; (ii) MPI or its directors, officers, employees, agents or delegates; and (iii) Snoman and its affiliated associations, volunteers, members, directors, officers, employees, agents or delegates (collectively, the "Indemnified Parties"), including but not limited to, claims either directly or indirectly relating to death, injury to persons, loss or damage to property, economic loss or incidental or consequential damages in connection with the use of the Snoman trail system notwithstanding that the same may have been caused by, or contributed to, the negligence or gross negligence of any of the Indemnified Parties.

You agree that if any other persons are permitted to operate or ride on the snowmobile or snow machine and any other equipment on these trails that you will advise such persons that they are also subject to the Waiver of Liability set out above, and that by operating or riding on such snowmobile or snow machine and any other equipment they agree to such Waiver of Liability. You further agree to save harmless and indemnify each of the Indemnified Parties from and against every claim which may be advanced by any operators or riders of such snowmobiles or snow machines and any other equipment or any third party, including but not limited to, claims either directly or indirectly relating to death, injury to persons, loss or damage to property, economic loss or incidental or consequential damages or infringement of rights (including, without limitation, privacy rights), notwithstanding that the same may have been caused by, or contributed to, the negligence or gross negligence of the Indemnified Parties.

CONDITIONS.






## THIS IS NOT AN ORV MAP
